1 **JUDGMENT**

2 Pursuant to the September 6, 2016 Amended Order Granting the Motion for Final Approval of  
3 Class Action Settlement and Motion for Attorneys' Fees, Costs, and Class Representative  
4 Enhancement Payments, it is hereby **ORDERED, ADJUGED, AND DECREED** as follows:

5 1. Judgment in this matter is entered in accordance with, and incorporates by reference the  
6 findings of, the Court's Amended Order Granting the Motion for Final Approval of Class Action  
7 Settlement and Motion for Attorneys' Fees, Costs, and Class Representative Enhancement Payments  
8 ("Order Granting Final Approval") and the Parties' Joint Stipulation of Class Action Settlement  
9 ("Settlement Agreement"). Judgment is entered against Defendants Southern State, Inc. and Victor  
10 Alsmadi in favor of Plaintiffs Michelle Ross, Perry Brian, Participating Class Members, and Class  
11 Counsel Justice Law Corporation and Law Offices of Jong Yun Kim in the total amount of  
12 \$752,961.25. Unless otherwise provided herein, all capitalized terms used herein shall have the same  
13 meaning as defined in the Settlement Agreement.

14 2. As provided by the Order Granting Final Approval, all Class Members who did not  
15 timely and properly opt-out from the Settlement are banned from pursuing, or seeking to reopen, any  
16 of the Released Claims, as defined in the Settlement Agreement. Consistent with the definitions  
17 provided in the Settlement Agreement, the settlement class consists of: all current and former  
18 California-based salaried or exempt Insurance Sales Agents or person who held similar job titles  
19 and/or performed similar job duties employed by Defendants within the State of California at any time  
20 during the period from April 29, 2009 to July 1, 2013.

21 3. Without affecting the finality of the Judgment, the Court shall retain exclusive  
22 jurisdiction and continuing jurisdiction over the above-captioned action and the parties, including all  
23 Class Members, for purposes of enforcing the terms of the Judgment entered herein pursuant to  
24 California Code of Civil Procedure section 664.6 and California Rules of Court Rule 3.769(h).
